Governor and Legislative Leadership,

We, the undersigned Oklahoma clergy and institutional leaders - members and allies of VOICE (Voices Organized in Civic Engagement) - write in strong opposition to HB 4156 and urge our representatives to seek a better, more constructive approach to immigration policy that promotes safe and strong communities.

We agree with the need for targeted legislation to address crime and the illegal marijuana grow operations that are plaguing Oklahoma's rural areas. However, we need to address that issue in a focused way that targets actual crime. HB 4156, rather than doing that, would primarily impact honest, hard-working immigrant families who contribute in many positive ways to our communities. Please consider:

- It is impossible for law enforcement and other government officials to know by looking whether someone is a citizen, legal immigrant, or here without documents. Without a narrowly defined and focused approach, people who simply look Asian and Latino will be swept up in problematic identifications and actions.
- Immigrants are in fact far less likely to commit crimes than U.S. born citizens. Studies have shown that they are more likely to be employed and have

- families.[i] The vast majority of immigrants are good neighbors and upstanding community participants.
- Indiscriminately targeting undocumented people hurts tens of thousands of Oklahoma families. Approximately 170,000 Oklahomans are in mixed status families, where there is at least one undocumented person. 60,000 children live in families with at least one undocumented family member.[ii]

When we talk with law enforcement, we hear about the importance of building trust within communities and about focusing on real crime. When we talk with business leaders, we hear about the urgent need for solid and consistent employees. Instead, HB 4156 would be disastrous for families, church communities, and businesses. The cruelty of this legislation is not in keeping with our Oklahoma Standard, a state that since our beginning has been a community of indigenous and immigrant members.

Let's work together to find a better way forward.
